#### THE GRAND JURY CHARGES:

#### COUNT I

That on or about January 1, 2006, and continuing thereafter until on or about June 29, 2011, at Helena, Havre, Billings, Kalispell, Lewistown, Miles City, Missoula, and Three Forks, in the State and District of Montana, and elsewhere, the defendants, CHRISTOPHER WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL JAMES NICHOLS, together and with Richard Flor, Sherry Flor, Justin Flor, T.F.D., and others both known and unknown to the Grand Jury, knowingly and unlawfully conspired and agreed to manufacture,

distribute, and possess, with the intent to distribute, marijuana, a Schedule I controlled substance, in violation of 21 U.S.C. § 841(a)(1).

## OBJECTS OF THE CONSPIRACY

The objects of the conspiracy were to: (1) manufacture 100 or more marijuana plants; (2) possess with the intent to distribute 100 or more kilograms of a substance containing a detectable amount of marijuana; (3) distribute 100 or more kilograms of a substance containing a detectable amount of marijuana; and (4) use proceeds from said criminal activities for their own financial benefit and to perpetuate the conspiracy.

#### MEANS AND METHODS

To accomplish the objects of the conspiracy, the conspirators employed the following means and methods:

1. During the time period of the conspiracy, CHRISTOPHER WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL JAMES NICHOLS, and their coconspirators grew marijuana plants at locations in Helena, Miles City, and Three Forks, Montana. The facility in Miles City, Montana, was a home occupied by coconspirators Richard Flor, Sherry Flor, and Justin Flor.

- 2. During the time period of the conspiracy, marijuana manufactured at the locations described above and obtained from other sources was possessed for distribution and distributed by CHRISTOPHER WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL JAMES NICHOLS, and their coconspirators at distribution points in Billings, Helena, Miles City, and Missoula, Montana. Those locations included: 2325 Ninth Avenue North, Billings, Montana; 3790 Highway 12 West, Helena, Montana; 3213 Highway 12 West, Helena, Montana; 412 South Stacy Avenue, Miles City, Montana; and 1935 Brooks Street, Missoula, Montana.
- 3. During the time period of the conspiracy, CHRISTOPHER
  WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL
  JAMES NICHOLS, and their coconspirators possessed firearms in
  order to facilitate the drug trafficking crimes that were the objects of
  the conspiracy, namely to protect caches of marijuana plants,
  marijuana, and proceeds obtained from the distribution of marijuana,
  and to intimidate those who challenged the manner in which conspiracy
  was conducted. Such firearms included both pistols and rifles,
  including semi-automatic, assault-style rifles.

4. Some proceeds obtained from the manufacture and distribution of marijuana pursuant to the conspiracy were deposited in bank accounts and distributed among CHRISTOPHER WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL JAMES NICHOLS, and their coconspirators. Other proceeds from the manufacture and distribution of marijuana were deposited in bank accounts and ultimately employed to further the objects of the conspiracy by providing the financial means to continue the manufacture and production of marijuana.

All in violation of 21 U.S.C. § 846.

## COUNT II

That on or about January 1, 2006, and continuing thereafter until on or about March 15, 2011, at Helena, Miles City, and Three Forks, in the State and District of Montana, the defendants, CHRISTOPHER WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL JAMES NICHOLS, and Richard Flor, Sherry Flor, Justin Flor, and T.F.D knowingly manufactured 100 or more marijuana plants, a Schedule I controlled substance, in violation of 21 U.S.C. § 841(a)(1).

## **COUNT III**

That on or about March 14, 2011, at Miles City, in the State and District of Montana, the defendants, CHRISTOPHER WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL JAMES NICHOLS, and Richard Flor, Sherry Flor, Justin Flor, and T.F.D. knowingly possessed, with the intent to distribute, a substance containing a detectable amount of marijuana, a Schedule I controlled substance, in violation of 21 U.S.C. § 841(a)(1).

#### COUNT IV

That on or about March 14, 2011, at Billings, in the State and District of Montana, the defendants, CHRISTOPHER WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL JAMES NICHOLS, and Richard Flor, Sherry Flor, Justin Flor, and T.F.D. knowingly possessed, with the intent to distribute, a substance containing a detectable amount of marijuana, a Schedule I controlled substance, in violation of 21 U.S.C. § 841(a)(1).

#### COUNT V

That on or about March 14, 2011, at Helena, Miles City, and Billings, in the State and District of Montana, the defendants,

CHRISTOPHER WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL JAMES NICHOLS, and Richard Flor, Sherry Flor, Justin Flor, and T.F.D. knowingly possessed a firearm, namely:

That on or about March 14, 2011, at Helena, in the State and District of Montana, the defendants, CHRISTOPHER WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL JAMES NICHOLS, and Richard Flor, Sherry Flor, Justin Flor, and T.F.D. knowingly possessed a firearm, namely:

during and in furtherance of the drug trafficking crime charged in Count III above, a crime that may be prosecuted in a court of the United States, in violation of 18 U.S.C. § 924(c).

#### COUNT VIII

That on or about March 14, 2011, at Billings, in the State and District of Montana, the defendants, CHRISTOPHER WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL JAMES NICHOLS, Richard Flor, Sherry Flor, Justin Flor, and T.F.D. knowingly possessed a firearm, namely a Springfield Armory, Model XD40, .40-caliber semi-automatic pistol (serial number US494255), during and in furtherance of the drug trafficking crime charged in Count IV above, a crime that may be prosecuted in a court of the United States, in violation of 18 U.S.C. § 924(c).

#### **COUNT IX**

That on or about March 14, 2011, near Helena, in the State and District of Montana, the defendant, DANIEL JAMES NICHOLS, who was previously convicted on May 13, 1985, of a crime punishable by a term of imprisonment exceeding on year under the laws of the State of Montana, knowingly possessed, in and affecting interstate and foreign

commence, firearms and ammunition, namely a Browning .22 caliber pistol (serial number 64909P6), a SAKO .270 caliber rifle (serial number 202885), a Ruger .223 caliber rifle (serial number 783-80583), a Browning .22 caliber rifle (no serial number), 32 rounds of .44 magnum ammunition, and four rounds of .223 caliber ammunition, in violation of 18 U.S.C. 922(g)(1).

#### PINKERTON THEORY OF LIABILITY

Counts II through VIII are subject to a *Pinkerton* theory of liability.

## FORFEITURE ALLEGATION

Upon conviction of the offenses charged in this indictment, the defendants, CHRISTOPHER WAYNE WILLIAMS, CHRISTOPHER J. LINDSEY, and DANIEL JAMES NICHOLS, shall forfeit to the United States, pursuant to 18 U.S.C. § 924(d) and 21 U.S.C. § 853, any and all real or personal property constituting proceeds and derived from any proceeds the defendants obtained directly and indirectly as a result of said violations, and any and all property used and intended to be used in any manner to commit and to facilitate the commission of the drug

trafficking violations and firearms violations alleged in the indictment, including but not limited to the following:

#### I. CASH PROCEEDS

At least \$1,728,000 that was received in exchange for the manufacture and distribution of controlled substances and is traceable thereto.

#### II. BANK ACCOUNTS

All U.S. currency funds and other monetary instruments credited to account number xxxxxx4966 in the name of Montana Caregiver's Association, P.O. Box 7327, Helena, Montana, located at Wells Fargo Bank.

All U.S. currency funds and other monetary instruments credited to account number xxx3852 in the name of Montana Caregiver's Association, P.O. Box 7327, Helena, Montana, located at Valley Bank, including \$29,871.72 seized on March 14, 2011.

All U.S. currency funds and other monetary instruments credited to account number xxx3712 in the name of Montana Caregiver's Association, P.O. Box 7327, Helena, Montana, located at Valley Bank, including \$552.79 seized on March 14, 2011.

## III. SUBSTITUTE ASSETS AND MONEY JUDGMENT

If any of the above-described forfeitable property, as a result of any act or omission of the defendants –

- (1) cannot be located upon the exercise of due diligence;
- (2) has been transferred or sold to, or deposited with, a third party;
- (3) has been placed beyond the jurisdiction of the Court;
- (4) has been substantially diminished in value; or
- (5) has been commingled with other property which cannot be divided without difficulty;

it is the intent of the United States, pursuant to 21 U.S.C. § 853(p), to seek forfeiture of any other property of said defendants up to the value of the forfeitable property described above. If sufficient property is not forfeited in satisfaction of the total value of property ordered forfeited by the Court, the United States will seek a money judgment against the
