This is a request for removal of my personally identifiable information from the uscourts.gov, gpo.gov, and pacermirror.com websites. If such a request requires a formal motion, please treat this as a Motion to Seal.

There are several hate groups targeting me, publishing my personal information on their websites and encouraging others to stalk and harass me. The Southern Poverty Law Center recognizes these individuals and organizations as hate groups that target LGBT people. They use these government website publications to locate me and further target my family and I. There is a pending FBI investigation and I have also filed criminal complaints with the Orange County Sheriff (California) and the California Attorney General.

I have received hateful emails, death threats, and in November 2018 an individual associated with the hate groups contacted my employer. As a result, my employer used said communication and your online publications as reason to terminate my employment. I am currently unemployed.

I believe the safety and privacy of my family and I outweighs any public interest in these District Court cases. All of these opinions are non-precedential. In the case of my criminal appeals, all the convictions are over 10 years old and I have been permanently removed from all state registries. I have not had a single arrest, charge, or conviction in over a decade.

Because of the constant harassment and stalking, I have enrolled in the California Safe At Home program. This program is intended to protect my privacy, especially online. This allows me to request any government agency or business to remove personally identifiable information from the Internet or other publications. I have included a copy of my Safe At Home Certificate and an Opt-Out / Removal form for the US District Court of Maine.


