PETITION


COMES NOW, Jennifer Howell-Wright, Plaintiff, by and through her attorney, Josh Hutchins, and for her cause of action against the Defendant alleges and states as follows:

1. The Plaintiff and the Defendant are both the natural grandparents of a minor child, Jaxon Howell.
2. Plaintiff is the natural mother of Bailey Howell, the father of Jaxon Howell.
3. Defendant is the natural mother of Bonnie Hoover, the mother of Jaxon Howell.
4. Jaxon Howell is the subject of an ongoing guardianship matter under the case number of PG-20-45, which is fully incorporated herein by reference.
5. Bailey Howell and Bonnie Hoover each voluntarily consented to the Petitioner being guardian of their child, Jaxon Howell. Said consents are fully incorporated herein by reference.
6. Jennifer Howell-Wright, the Petitioner, is the duly appointed guardian of Jaxon Howell.
7. Defendant has made certain inflammatory, false, libelous, and slanderous statements against the Plaintiff on social media, examples of such are attached as Exhibit A.
8. Plaintiff has, via her attorney, cautioned the Defendant against making further such comments, but said warning was ignored.
9. Defendant's comments have damages Plaintiff's reputation in the community and she has suffered severe mental and emotional distress.

- 10. Plaintiff, by nature of her career, is a "Mandatory Reporter" for suspected or perceived child neglect or abuse.
- 11. Defendant's comments threaten her career stability.

WHEREFORE, Plaintiff prays for this Court to issue a temporary restraining order and a temporary injunction restraining the Defendant from making public comment concerning the ongoing above-described guardianship, that the Defendant be judged guilty of both slander and libel, and for immediate hearing on temporary restraining order, temporary injunction, for actual and punitive damages of \$75,000.00, and for reasonable attorney's fees and the costs of this action.



Bonnie and I share a birthday and we share a mutual heartache. Today, my daughter turns 21 and she wants to be able to spend alone time with her son.

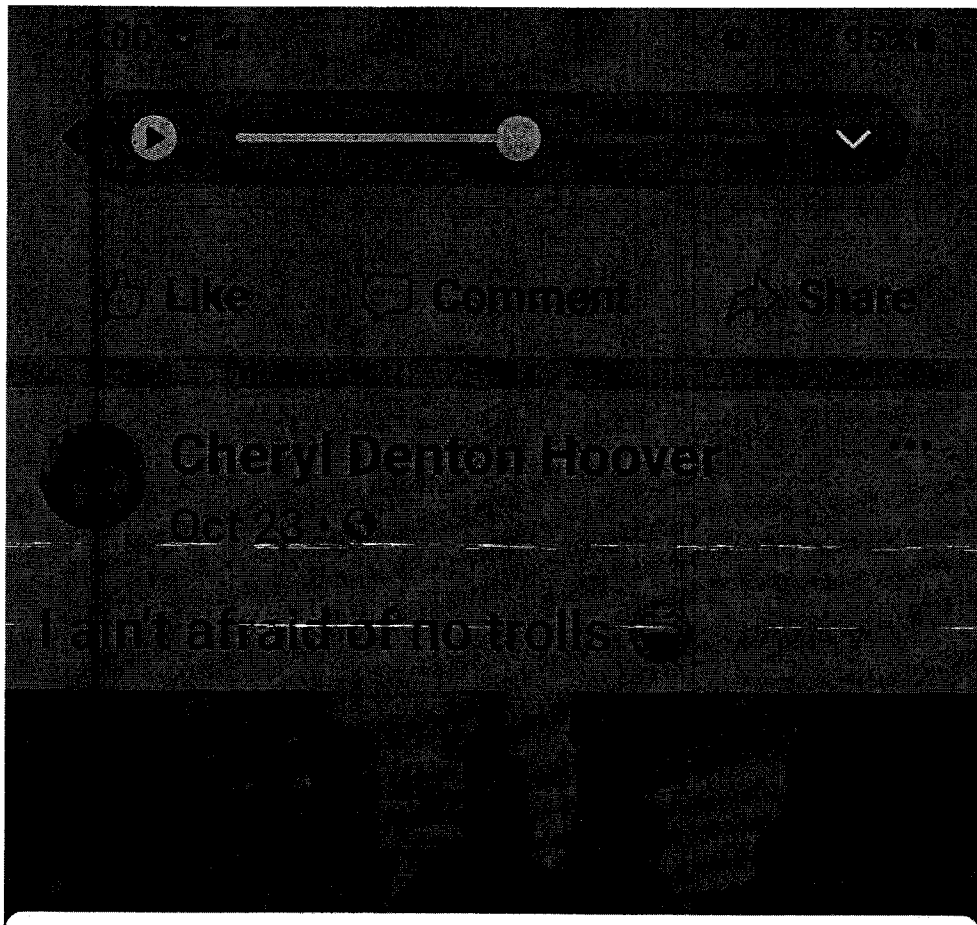
There is absolutely NO reason why she can't. Bonnie is a great momma and has not done anything to deserve this action.

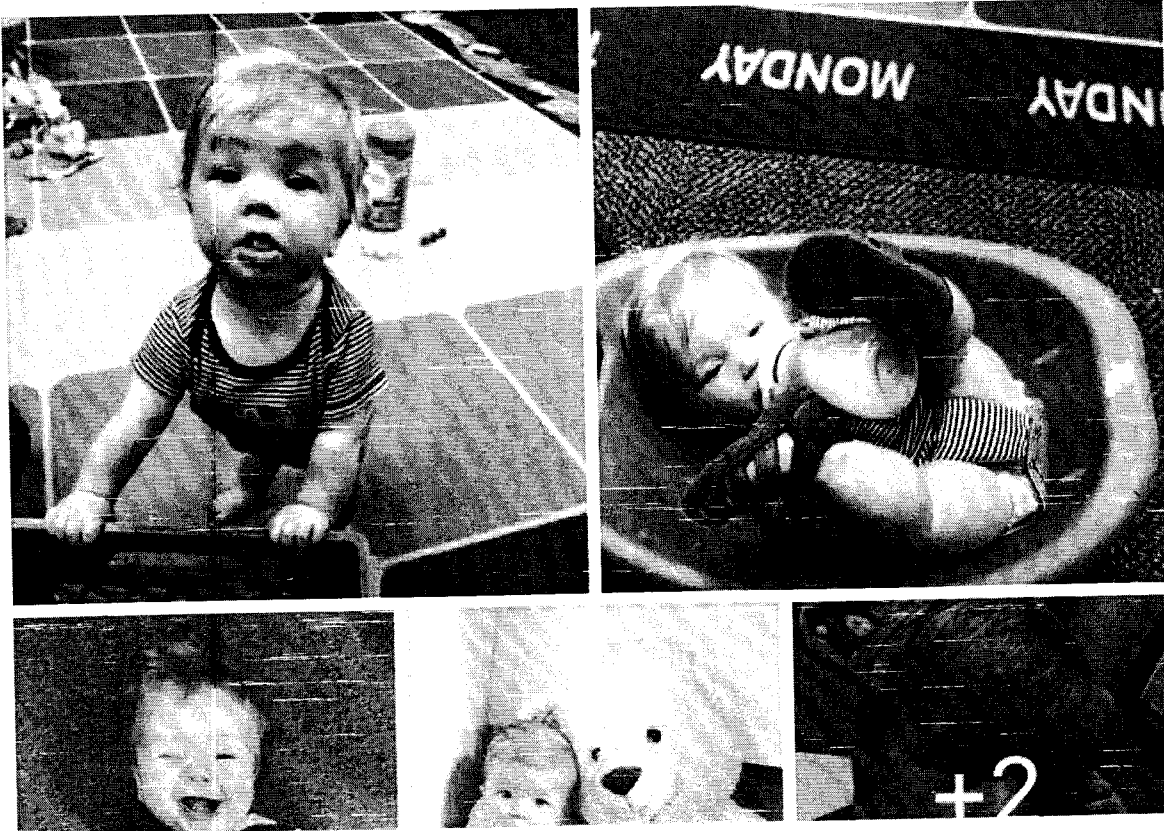
