Narrative

Sgt. notes that at approx. the 23 min marker from Sgt's rear in car camera system, accused GREEN (Post miranda) while talking to his brother begins to talk about how he should have taken another route or left. GREEN then says "I ain't trippin, I am going to take my lick!" GREEN then says "it's overwith for me, and then something to do about fingerprints on the gun.

GREEN was asked why he did not disclose that he had a pistol on him and he stated "I DIDN'T WANT TO GO TO JAIL!" Sgt. asks GREEN if he is a prohibited possessor and GREEN responds that he has not been convicted of a felony.

At approx. the 1 hour 5 min marker on the rear DMVR video, GREEN states "WHAT THE FUCK! THEY GOT THAT GUN! MY MOMMA LET THEM IN, WHAT THE FUCK!" at which time [REDACTED] says "SAY THEY FOR EDDIE!" GREEN was referring to a .223 rifle and Shot gun located in a bedroom that GREEN sometimes shares with [REDACTED] (according to the mother) after she provided both verbal (BWCR) and Written consent to search their bedroom.

At approx. the 1 hour 14 min marker, GREEN tells [REDACTED] when he is let loose, "go straight to Brookstown and tell them, look them dead in their face and tell them N-&*(they better move out of state!"

GREEN appeared very angry and agitated while in the rear of the police unit and repeatedly told his brother he was taking his lick and was done, indicating he was going to prison for a while.
