INCIDENT DETAILS:

On 09/27/22 at approximately 1008 hours, Troop F-Milton was contacted by White Deer Run Treatment Center regarding a patient who was reporting being raped by a transportation employee on her way to the facility. The Victim / Actor, Raine Elizabeth RIDEOUT was reporting that she was raped by the Actor, Arthur Harry OISTER during the transport from Franklin County Prison to White Deer Run Treatment Center. RIDEOUT stated that during the transport, OISTER pulled the transportation van off a dirt path which lead down near the Susquehanna River. This location was determined to be in the area of 4751 South Susquehanna Trail, Union Township, Snyder County.

During the investigation it was determined that RIDEOUT and OISTER pre-planned oral consensual sex that was performed by OISTER in the amount of \$20.00. OISTER had been employed by White Deer Run Treatment Center as a transportation driver for approximately 10 years, and RIDEOUT was court ordered to be at the facility by the Franklin County Probation Department.

On 10/12/22 both RIDEOUT and OISTER were arraigned in front of MDJ Bo TRAWITZ in Middleburg.

RIDEOUT was charged with Prostitution where she was lodged at Snyder County Prison.

OISTER was charged with Institutional Sexual Assault and Solicitation for Prostitution where bail was set in the amount of \$25,000 unsecured.
