INTRODUCTION

Beginning in August/July 2023 and continuing to the present day, Ms. Amy Gulley, of

using multiple aliases including but not limited to MrJusticeGossipGirl,

FyrestarOmega, along with several unidentified individuals using aliases (see EXHIBIT A) has orchestrated a prolonged and intensive campaign of cyberstalking and harassment, via the online social media platforms Reddit, X, and Facebook.

From August 2023 - September 2023, this stalking and harassing behavior took the form of multiple posts on a subreddit moderated by Ms. Amy Gulley under the alias Fyerstar Omega. It is believed that this harassment was instigated through Ms. Gulley's communications with Emeritus Professor Richard Gill, of Leiden University, Netherlands. On August 10, 2023, Prof. Gill had established with Dr. Adams the status of her educational qualifications. Subsequent to receiving this information, Prof. Gill doxed (exposed personal/private identifying information on an anonymous social media platform) Dr. Adams to Ms. Gulley, apparently encouraging her to initiate a smear campaign against Dr. Adams for the purposes of substantially harming her career and business prospects. On August 23, 2023, Ms. Gulley under the alias Fyrestar Omega began making false and unsubstantiated claims about Dr. Adams' educational credentials. Ms. Gulley had obtained this erroneous and false information from Prof. Gill.

At this same time, Prof. Gill was spreading numerous false claims about Dr. Adams educational credentials across social media platforms including on his own blog. (EXHIBIT D) Crucially, Prof. Gill appears to be the primary source of the many false claims made about Dr. Adams. Prof. Gill falsely claimed to others that he was an associate of Dr. Adams and intimated that he had a long history with Dr. Adams. In reality, Dr. Adams had no past relationship with Prof. Gill, and had only met with him on two/three prior occasions, the first time being in May 2023. Each meeting was as part of a wider group meeting, and no personal discussions took place.

Beginning August 2023, Prof. Gill made repeated false claims that Dr. Adams had experienced various mental health crises, and had dropped out of her PhD Program in 2017. He stated that she had failed to complete her PhD dissertation, and that she was misrepresenting herself. Prof. Gill was firmly aware that he either had no information supporting his claims, or worse that he was fabricating this information simply to inflict reputational damage on Dr. Adams. Although not relevant to this present request, Prof. Gill's behavior was apparently motivated by a perceived slight owing to Dr. Adams not wishing to collaborate with him on a professional basis. Notably, Prof. Gill had previously displayed this pattern of behavior towards other science professionals, where in one instance he was implicated in a two year long series of investigations having falsely accused scientists outside his discipline of fraud, plagiarism, and dishonesty. Prof. Gill was required to submit a statement recanting his false claims.

As a consequence of Prof. Gill's action, Ms. Gulley, either separately or as a part of a wider strategy, initiated a stalking and harassing campaign beginning on September 28, 2023, under the new alias MrJusticeGossipGirl. This behavior has taken the form of a curated subreddit solely targeting Dr. Adams and her business Science on Trial, Inc, along with over 3000 Twitter posts of the same nature. These posts set out to persistently smear, and defame Dr. Adams, and harm her ability to conduct her business.

SUMMARY OF AMY GULLEY'S STALKING AND HARASSING BEHAVIOR

Beginning in August 2023, and continuing to this day, Ms. Gulley repeatedly and falsely claims that Sarrita
Adams is a 'fake', 'a fraud', and a 'charlatan,' and that she is running her business for unlawful purposes.
 (EXHIBIT B). Ms. Gulley has no personal or professional relationship with Dr. Adams nor her

business. In plain language, Ms. Gulley is an internet stalker, who struggles to separate her online obsessions with real life.

- Ms. Gulley, under the alias MrJusticeGossipGirl has created a subreddit page under the handle https://www.reddit.com/r/scienceontrial this subreddit consists of 100s of posts.). The subreddit created by Ms. Gulley uses the name of Dr. Adams California Incorporated Business, Science on Trial, Inc, this is aimed at impersonating the business to attract potential customers. (EXHIBIT B)
- 3. Ms. Gulley additionally claims, without evidence that Sarrita Adams lied about her educational qualifications. This claim forms a significant basis of her harassing conduct, where she repeatedly states that Sarrita Adams should not be trusted under the basis that Ms. Gulley believes that Adams educational qualifications from the University of Cambridge cannot be substantiated by Ms. Gulley individually (EXHIBIT C). Importantly Ms. Gulley has no cause or basis to inquire or investigate any element of Adams' life and it is apparent that she is doing so simply due to a disturbed obsession.
- I. Ms. Gulley's reddit posts reveal a disturbed harassment campaign, where she demonstrates clear cut cyberstalking actions, where she "willfully, maliciously, and repeatedly follows or harasses someone and makes a credible threat with the intent to place the victim or their family in reasonable fear for their safety." (Penal Code § 646.9).
- 5. Ms. Gulley details how she has repeatedly sought to disrupt the business operations of Dr. Adams company, Science on Trial, Inc through using numerous fake aliases to contact the business making frivolous inquiries and accusations. Ms. Gulley has posted the evidence of this conduct on the subreddit used to harass Dr. Adams. (See EXHIBIT E)
- 6. Ms. Gulley has further demonstrated harassing behavior through selectively referencing portions of Dr. Adams' contentious divorce proceedings, even going so far as to reference portions from an unpublished court of appeal opinion (EXHIBIT F). Despite clear guidelines stipulating that unpublished opinions cannot be relied upon by parties outside of the original action, Ms. Gulley cites from the opinion; fully aware that she is not permitted to rely on the contents of the opinion to claims her assertions are grounded in fact. Importantly, Ms. Gulley uses the opinion to bolster unfounded allegations regarding the difficulties in Dr. Adams' marriage, thereby portraying Dr. Adams in a deliberately negative light, for the purposes of harming her reputation.

7. Ms. Gulley engaged in threatening conduct, by clearly stating that the creation of her subreddit exists for the sole purpose of damaging Dr. Adams' reputation. Ms. Gulley has repeatedly stated that she will continue to maintain her stalking and harassment until she stops Dr. Adams from running Science on Trial, Inc. (EXHIBIT G - See Tweets). As an example Ms. Gulley has stated in Twitter/X post:

- 8. Along with the subreddit account Ms. Gulley has established a Twitter/X account under the alias MrJusticeGossipGirl. (EXHIBIT 6) This account is solely focused at harassing Dr. Adams and her business. In the profile header Ms. Gulley prominently features a link to her subreddit account. Ms. Gulley and her aliases have posted over 3000 tweets since October 2023 focused on harassing Dr. Adams.
- 9. Ms. Gulley encourages other anonymous users of the social media platforms to stalk, harass and intimidate Dr. Adams (EXHIBIT A).
- 10. Ms. Gulley's conduct is intended to induce fear, and distress in Dr. Adams. This is being achieved owing to her subreddit posts featuring prominently in Google searches of Dr. Adams and her business, Science on Trial, Inc. (EXHIBIT H summary google results)
- 11. Ms. Gulley has engaged in a widespread stalking campaign through Reddit and Twitter/X where she details her ongoing pattern of following Dr. Adams online, throughout the day, on a daily basis. Ms. Gulley's identification was determined through her statement that she had been following Dr. Adams on LinkedIn, on May 28, 2024. A search of visits to Dr. Adams' LinkedIn page reveals that Ms. Gulley was the individual that visited Dr. Adams LinkedIn page (EXHIBIT I). It was already known to Dr. Adams that Ms. Gulley was associated with a reddit account under the username FyrestarOmega.

DECLARATION OF FLORIDE ROSA BELLINI IN SUPPORT OF A CIVIL HARASSMENT ORDER

I, Floride Rosa Bellini, declare as follows:

- I have personally witnessed the behavior of Amy Gulley, also known by her aliases FyrestarOmega and MrJusticeGossipGirl, which has constituted a prolonged and intensive campaign of cyberstalking and harassment directed at Dr. Sarrita Adams. This behavior has been ongoing since at least August 2023.
- 2. I have made repeated efforts to stop this behavior by directly communicating with Ms. Gulley. Despite my multiple attempts to address and resolve the issue through dialogue and reasoning, Ms. Gulley has consistently refused to cease her actions. She has shown a clear intent to continue her harassment campaign, which has included defamatory and false statements about Dr. Adams' professional and personal life.
- 3. On Monday, June 3, 2024, I took the step of contacting Ms. Gulley via LinkedIn. In my message, I explicitly requested that she stop harassing Dr. Adams and remove the abusive subreddit she had created, which was dedicated to defaming and discrediting Dr. Adams and her business, Science on Trial, Inc.
- 4. Within one hour of sending this message to Ms. Gulley, she deleted her entire LinkedIn account. This sudden action suggests an acknowledgment of her wrongful conduct and an attempt to evade further

accountability. Concurrently, she began the process of deleting the numerous Reddit posts she had made under the alias PyrestarOmega, which were part of her sustained harassment campaign against Dr. Adams.

- I am also aware that Amy Gulley operates under the alias MrJusticeGossipGirl. This alias has been used
 extensively to further her harassment campaign against Dr. Adams on various social media platforms,
 including Reddit and Twitter/X.
- 6. Despite these actions, it is clear that Ms. Gulley has only taken these steps in response to being confronted directly and that her underlying intent to harm and harass Dr. Adams remains unchanged. Her previous behavior and her evasive response indicate a pattern of malicious conduct intended to cause distress and damage to Dr. Adams' reputation and professional standing.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.

To the Person in 1:

- The court cannot make the restraining orders after the court hearing unless the person in ② has been personally given (served) a copy of your request and any temporary orders. To show that the person in ② has been served, the person who served the forms must fill out a proof of service form. Form CH-200, *Proof of Personal Service*, may be used.
- For information about service, read form CH-200-INFO, What Is "Proof of Personal Service"?
- You may ask to reschedule the hearing if you are unable to find the person in (2) and need more time to serve the documents, or for other good reasons. Read form CH-115-INFO, How to Ask for a New Hearing Date.
- You must attend the hearing if you want the judge to make any of the orders you requested on form CH-100, Request for Civil Harassment Restraining Orders. Bring any evidence or witnesses you have. For more information, read form CH-100-INFO, Can a Civil Harassment Restraining Order Help Me?

Warnings and Notices to the Restrained Person in 2

You Cannot Have Firearms (Guns), Firearm Parts, or Ammunition

You cannot own, have, possess, buy or try to buy, receive or try to receive, or otherwise get any prohibited items listed in item 7b on page 3 while this Order is in effect. If you do, you can go to jail and pay a \$1,000 fine. You must sell to or store with a licensed gun dealer, or turn in to a law enforcement agency, any firearms (guns) and firearm parts that you have or control as stated in item (7) above. The court will require you to prove that you did so.

Notice Regarding Nonappearance at Hearing and Service of Order

If you have been personally served with this Temporary Restraining Order and form CH-109, *Notice of Court Hearing*, but you do not appear at the hearing either in person or by a lawyer, and a restraining order that is the same as this Temporary Restraining Order except for the expiration date is issued at the hearing, a copy of the order will be served on you by mail at the address in item (2).

If this address is not correct or you wish to verify that the Temporary Restraining Order was converted into a restraining order at the hearing without substantive change, or to find out the duration of the order, contact the clerk of the court.

After You Have Been Served With a Restraining Order

- You must have form CH-120 served by mail on the person in ① or that person's attorney. You cannot do this yourself. The person who does the mailing should complete and sign form CH-250, *Proof of Service by Mail*. File the completed proof of service with the court clerk before the hearing date or bring it with you to the hearing.

Instructions for Law Enforcement

Enforcing the Restraining Order

This order is enforceable by any law enforcement agency that has received the order, is shown a copy of the order, or has verified its existence on the California Restraining and Protective Orders System (CARPOS). If the law enforcement agency has not received proof of service on the restrained person, the agency must advise the restrained person of the terms of the order and then must enforce it. Violations of this order are subject to criminal penalties.

Start Date and End Date of Orders

This order starts on the date next to the judge's signature on page 4. The order ends on the expiration date in item (4) on page 1.

Arrest Required if Order Is Violated

If an officer has probable cause to believe that the restrained person had notice of the order and has disobeyed the order, the officer must arrest the restrained person. (Pen. Code, §§ 836(c)(1), 13701(b).) A violation of the order may be a violation of Penal Code section 166 or 273.6. Agencies are encouraged to enter violation messages into CARPOS.

Notice/Proof of Service

The law enforcement agency must first determine if the restrained person had notice of the order. Consider the restrained person "served" (given notice) if (Pen. Code, § 836(c)(2)):

- The officer sees a copy of the Proof of Service or confirms that the Proof of Service is on file; or
- The restrained person was informed of the order by an officer.

An officer can obtain information about the contents of the order and proof of service in CARPOS. If proof of service on the restrained person cannot be verified, the agency must advise the restrained person of the terms of the order and then enforce it.

If the Protected Person Contacts the Restrained Person

Even if the protected person invites or consents to contact with the restrained person, this order remains in effect and must be enforced. The protected person cannot be arrested for inviting or consenting to contact with the restrained person. The order can be changed only by another court order. (Pen. Code, § 13710(b).)

Conflicting Orders—Priorities for Enforcement

If more than one restraining order has been issued protecting the protected person from the restrained person, the orders must be enforced in the following priority (see Pen. Code, § 136.2 and Fam. Code, §§ 6383(h)(2), 6405(b)):

- 1. Emergency Protective Order (EPO): If one of the orders is an Emergency Protective Order (form EPO-001), provisions (e.g., stay-away order) that are more restrictive than in the other restraining/protective orders must be enforced. Provisions of another order that do not conflict with the EPO must be enforced.
- 2. No-Contact Order: If a restraining/protective order includes a no-contact order, the no-contact order must be enforced. Item 5a(2) is an example of a no-contact order.
- 3. Criminal Protective Order (CPO): If none of the orders include an EPO or a no-contact order, the most recent CPO must be enforced. (Fam. Code, §§ 6383(h)(2) and 6405(b).) Additionally, a CPO issued in a criminal case involving charges of domestic violence, Penal Code sections 261, 261.5, or former 262, or charges requiring sex offender registration must be enforced over any civil court order. (Pen. Code, § 136.2(e)(2).) All provisions in the civil court order that do not conflict with the CPO must be enforced.
- 4. Civil Restraining Orders: If there is more than one civil restraining order (e.g., domestic violence, juvenile, elder abuse, civil harassment), then the order that was issued last must be enforced. Provisions that do not conflict with the most recent civil restraining order must be enforced.
