4 That beginning on a date unknown, but by on or about June 1, 2011, until on or  
5 about August 16, 2012, in the Eastern District of Washington, and elsewhere, the  
6 Defendants, RHONDA LEE FIRESTACK-HARVEY, LARRY LESTER HARVEY,  
7 MICHELLE LYNN GREGG, ROLLAND MARK GREGG, and JASON LEE  
8 ZUCKER, did knowingly and intentionally combine, conspire, confederate and agree  
9 together with each other and with other persons, both known and unknown to the Grand  
10 Jury, to commit the following offenses against the United States, to wit: Manufacture of  
11 100 or More Marijuana Plants and Distribution of Marijuana, in violation of 21 U.S.C. §  
12 841(a)(1); all in violation of 21 U.S.C. § 846.

16 COUNT 2

17 Beginning on a date unknown, but by on or about June 1, 2011, until on or about  
18 August 16, 2012, in the Eastern District of Washington, the Defendants, RHONDA LEE  
19 FIRESTACK-HARVEY, LARRY LESTER HARVEY, MICHELLE LYNN GREGG,  
20 ROLLAND MARK GREGG, and JASON LEE ZUCKER, knowingly and intentionally  
21 Manufactured 100 or more Marijuana plants, a Schedule I controlled substance, in  
22 violation of 21 U.S.C. § 841(a)(1), and 18 U.S.C. § 2.

5 ROLLAND MARK GREGG, and JASON LEE ZUCKER, knowingly and intentionally  
6 distributed Marijuana, a Schedule I controlled substance, in violation of 21 U.S.C. §  
7 841(a)(1), and 18 U.S.C. § 2.

11 That beginning on a date unknown, but by on or about July 1, 2012, until on or  
12 about August 9, 2012, in the Eastern District of Washington, the Defendants, RHONDA  
13 LEE FIRESTACK-HARVEY, LARRY LESTER HARVEY, MICHELLE LYNN  
14 GREGG, ROLLAND MARK GREGG, and JASON LEE ZUCKER did knowingly and  
15 willfully possess firearms, specifically: a Remington 870 Express Magnum 12 guage  
16 shotgun with serial number C645218M; a Ruger LC 9 9mm pistol serial number 320-  
17 76596; and a Tradewinds Husky model H-5000 7mm mag rifle serial number 324920,  
18 in furtherance of a drug trafficking crime, to wit: Conspiracy to Manufacture 100 or  
19 More Marijuana Plants, in violation of 21 U.S.C. § § 841(a)(1) and 846; Manufacture  
20 of 100 or more Marijuana plants in violation of 21 U.S.C. § 841(a)(1); and Distribution  
21 of Marijuana in violation of 21 U.S.C. § 841(a)(1), and 18 U.S.C. § 2; all in violation  
22 of 18 U.S.C. § 924(c)(1)(A)(i).

6 and intentionally used and maintained a place at 939 Clugston- Onion Creek Rd.  
7 Colville, Washington, either temporarily or permanently, for the purpose of  
8 manufacturing, distributing, and using Marijuana, a Schedule I controlled substance, in  
9 violation of 21 U.S.C. § 856(a)(1), and 18 U.S.C. § 2.
