The Grand Jury Charges:

COUNT 1

That beginning on a date unknown, but by on or about June 1, 2011, until on or about August 16, 2012, in the Eastern District of Washington, and elsewhere, the Defendants, RHONDA LEE FIRESTACK-HARVEY, LARRY LESTER HARVEY, MICHELLE LYNN GREGG, ROLLAND MARK GREGG, and JASON LEE ZUCKER, did knowingly and intentionally combine, conspire, confederate and agree together with each other and with other persons, both known and unknown to the Grand Jury, to commit the following offenses against the United States, to wit: Manufacture of 100 or More Marijuana Plants and Distribution of Marijuana, in violation of 21 U.S.C. § 841(a)(1); all in violation of 21 U.S.C. § 846.

COUNT 2

Beginning on a date unknown, but by on or about June 1, 2011, until on or about August 16, 2012, in the Eastern District of Washington, the Defendants, RHONDA LEE FIRESTACK-HARVEY, LARRY LESTER HARVEY, MICHELLE LYNN GREGG, ROLLAND MARK GREGG, and JASON LEE ZUCKER, knowingly and intentionally Manufactured 100 or more Marijuana plants, a Schedule I controlled substance, in violation of 21 U.S.C. § 841(a)(1), and 18 U.S.C. § 2.

On or about and between October 23, 2011 and November 18, 2011, in the Eastern District of Washington, the Defendants, RHONDA LEE FIRESTACK-HARVEY, LARRY LESTER HARVEY, MICHELLE LYNN GREGG, ROLLAND MARK GREGG, and JASON LEE ZUCKER, knowingly and intentionally distributed Marijuana, a Schedule I controlled substance, in violation of 21 U.S.C. § 841(a)(1), and 18 U.S.C. § 2.

That beginning on a date unknown, but by on or about July 1, 2012, until on or about August 9, 2012, in the Eastern District of Washington, the Defendants, RHONDA LEE FIRESTACK-HARVEY, LARRY LESTER HARVEY, MICHELLE LYNN GREGG, ROLLAND MARK GREGG, and JASON LEE ZUCKER did knowingly and willfully possess firearms, specifically: a Remington 870 Express Magnum 12 guage shotgun with serial number C645218M; a Ruger LC 9 9mm pistol serial number 320-76596; and a Tradewinds Husky model H-5000 7mm mag rifle serial number 324920, in furtherance of a drug trafficking crime, to wit: Conspiracy to Manufacture 100 or More Marijuana Plants, in violation of 21 U.S.C. § 841(a)(1) and 846; Manufacture of 100 or more Marijuana plants in violation of 21 U.S.C. § 841(a)(1); and Distribution of Marijuana in violation of 21 U.S.C. § 841(a)(1), and 18 U.S.C. § 2; all in violation of 18 U.S.C. § 924(c)(1)(A)(i).
